| SANCTION: | Held under the sanctioned of USA Swimming Inc., issued by Georgia Swimming, Inc.: Sanction No. GA17-104 |
| HOST: | Athens Bulldog Swim Club |
| FACILITY: | <p>The meet will take place in University of Georgia's Ramsey Center, Gabrielsen Natatorium's state of the art 50m x 25yd competition pool. An eight lane 25 yard course will be used for competition during the meet. An eight lane 25 yd warm-up/down pool will be available throughout the course of the meet. A Colorado System 6 automatic timing system, non-slip touch pads, non-turbulent lane lines, and two 8-lane score boards will be used.</p> <p>The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.</p> |
| ELIGIBILITY: | Open to members of ABSC only. No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302. |
| RULES: | <p>The 2017 USA Swimming rules will govern the conduct of this meet. Swimmers will be responsible for swimming in the proper heat and lane. All swimmers, teams and coaches must be USA-registered and coaches will be asked to show their registration. All officials must present, at check-in, their current LSC Officials Certification Card; <u>OR</u> a recently completed Apprentice Form; <u>AND</u> proof of current USA Swimming Non-Athlete membership. Officials must wear their credentials while on deck. Please Note: Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms. Deck Pass is acceptable proof of USA Swimming membership. On-deck registrations will not be permitted during this event. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. <u>Deck Changes are prohibited.</u> Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coaches' areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and /or spectators are present. Exceptions may be granted with prior written approval by the Vice President of Program Operations. Photos and videos may be taken of swimmers during the meet by parents or a professional photographer retained by the host club. All participants agree to be filmed or photographed by photographers designated by the meet host and to allow the meet host the right to use names, pictures, likenesses, and biographical information before, during, or after the period of participation in Georgia Swimming competitions to promote</p> |

If you do not wish to have your child(ren) photographed, you may withdraw your consent by informing the Meet Director before the start of the first day of the meet. If a swimmer who is not properly registered with USA Swimming competes in a sanctioned competition, the host LSC may impose a fine of up to \$100.00 per event against the individual, member coach or member club submitting the entry.</p> |
| SCHEDULE: | Warm-up will begin at 5:00 pm. The meet will begin at 5:45 pm. |
| FORMAT: | This will be a timed finals meet. |
| TIME STANDARDS: | This is an open meet with no time standards. |
| ENTRIES: | Swimmers may swim a maximum of four events and one relay. |
| ENTRY FEES: | \$25 per swimmer |
| ENTRY DEADLINE: | Entries must be in to the Meet Director by Friday, September 22 nd . |
| SCORING: | Points will be awarded as follows: Individual events: 9, 7, 6, 5, 4, 3, 2, 1. Relay points will be double the individual points, scoring three only. |
| WARM UPS: | Warm ups will be governed by the guidelines as adopted by Georgia Swimming, Inc. |
| WAIVER | In granting this sanction it is understood and agreed that USA Swimming shall be free and held harmless from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event. It is further understood that Georgia Swimming Inc., and Athens Bulldog Swim Club shall be free and held harmless from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event. |
